I hereby irrevocably waive, release and fully discharge Itty Bitty City from any and all liability for loss, damage, personal injury, including death and disability, and costs of any kind and nature whatsoever which I or the Child may suffer now or in the future by reason of or existing out of any causes whatsoever related to or arising out of or from the participation of the Child in the Activities or presence of the Child on the Premises.
- 6. ASSUMPTION OF RISK Participation in the Activities carries with it certain inherent risks which cannot be eliminated regardless of the care taken to avoid injuries. The specific risks may range from minor scratches, bruises and sprains to more serious injuries including disability and death. The participation of Child or me is voluntary and the risks are knowingly assumed.

INDEMNIFICATION and HOLD HARMLESS I also agree to indemnify and hold Itty Bitty City, LLC harmless from any and all claims, actions, suits, costs, damages and liabilities including attorney fees as a result of my or my Child's involvement in Activities and to reimburse Itty Bitty City, LLC for any such expenses incurred.

I UNDERSTAND THAT, BY SIGNING THIS AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I, THE CHILD, AND OUR RESPECTIVE HEIRS, ASSIGNS, EXECUTORS, ADMINISTRATORS, PERSONAL REPRESENTATIVES, AND NEXT OF KIN MAY HAVE AGAINST THE RELEASEES, INCLUDING THE RIGHT TO SUE. I SIGN THIS DOCUMENT VOLUNTARILY AND WITHOUT INDUCEMENT.
